



Epona EmailFiler Software License Agreement

PLEASE READ: BY USING OUR SOFTWARE, YOU ACCEPT THE TERMS AND CONDITIONS STATED BELOW IN A LEGALLY BINDING MANNER.

If you are obtaining the software as defined below on behalf of a company, you represent that you are duly authorized to represent the company and accept the terms and conditions of the agreement on behalf of the company. A binding contract is then formed between Epona Software Productions and the company in accordance with the terms of this agreement.

If the company you represent do not agree to the terms and conditions of this agreement, do not download or install the software.

ART. 1 GOVERNING LAW

ART. 2 REGISTERED VERSION

A single registered copy of Epona EmailFiler may either be used by a single person who uses the software himself on one computer, or installed on a single computer and used by multiple people. One copy or license of Epona EmailFiler cannot be installed on multiple computers and cannot be used at the same time. A license must be purchased for each computer on which Epona EmailFiler is installed.

You may access the registered version of Epona EmailFiler through a network or by using a terminal server, provided that you have obtained individual licenses for the software covering all computers and sessions that will run the software from the network. For instance, if six different workstations will access Epona EmailFiler on the network, you will need a six-user Epona EmailFiler license, whether they use Epona EmailFiler at different times or concurrently. When using Microsoft Windows Terminal Server, or Citrix terminal server or any other terminal server software, you need to purchase a separate license per user session.

Epona EmailFiler is not free software. Subject to the terms below, you are hereby licensed to use this software for evaluation purposes without charge for a period of 30 days.
